NATURE IN THE NEIGHBORHOOD

The Ruby-throated Hummingbird is the most commonly found hummingbird in Florida and can be seen in the Landings feeding on the nectar of shrimp plants, firespike shrubs, and trumpet honeysuckle. These birds are tiny, growing only nine centimeters and weighing less than seven grams. The male has a ruby throat, while the female's throat is white.
